Dear Mr. Height:

I am pleased to report Spring Branch West Super Neighborhood Council, Inc., Taxpayer Number 3-20031-0393-7, qualifies for exemption from the state franchise tax as a 501(c)(3) organization effective January 16, 2001. Since the account is in the process of being updated, you may receive franchise tax notices for periods covered by the exemption. In the event we have reason to believe the organization no longer qualifies for exemption, we will notify the registered agent that the exempt status is under review.

This corporation also qualifies for exemption from the Texas limited sales, excise, and use tax as a 501(c)(3) organization effective January 16, 2001. It may issue an exemption certificate instead of paying the state and local sales tax on taxable items if they relate to the purpose of the exempt organization and are not used for the personal benefit of a private member or individual. The enclosed certificate does not require a number to be valid, and you may reproduce it in any quantity.

The organization must notify the Secretary of State if it changes its name, registered agent, or registered office address.
